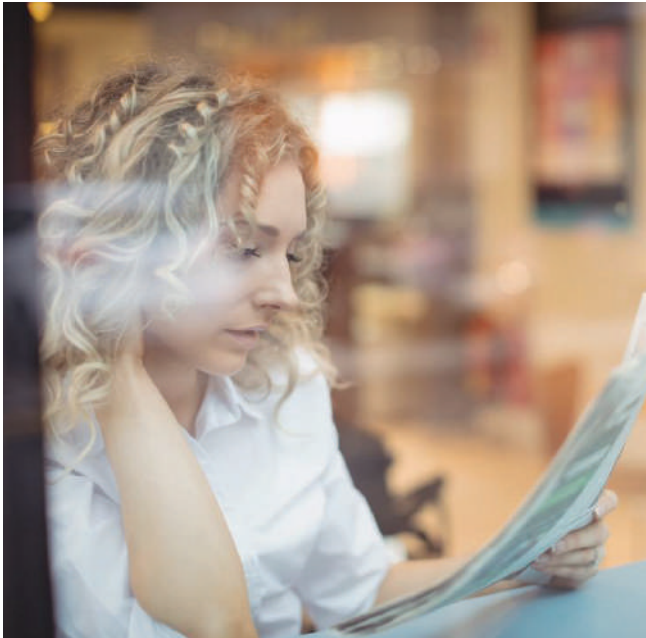
Marlene Beukes
